2 Introduction

It has natural sites such as mountains, lakes, in addition to 16 studios & more than 70 outdoor locations and new locations within its boundaries.

Maharashtra Film, Stage & Cultural Development Corporation Ltd. Punyashlok Ahilyadevi Holkar (1725–1795) was a legendary queen and administrator of the Holkar dynasty in Malwa. Her rule was marked by integrity, religious tolerance, infrastructure development, women's empowerment, and cultural patronage. This feature film aims to bring her story to a wide audience while promoting Indian heritage, womanled leadership narratives, and tourism to historically relevant sites.

3 Purpose

Identify qualified and visionary producers with the creative, technical, and financial ability to produce a compelling and historically accurate feature film.

Facilitate collaboration between MFSCDCL and creative partners for a film that serves both cultural and commercial objectives.

Promote the values of inclusive leadership, gender equity, and heritage through cinematic storytelling.

To release the film, statewide, nationwide, and finally, an international release to reach audiences at all levels. This approach ensures to build momentum and connect with diverse viewers at each levels.

4 Indicative Scope of Work

The selected applicant will undertake the end-to-end production of a feature film with the following thematic and creative scope:

4.1 Key Themes and Narrative Objectives

- Portrayal of Punyashlok Ahilyadevi Holkar's early life, education, and spiritual foundation.
- Punyashlok Ahilyadevi Holkar's transition from queen consort to sovereign leader after personal loss.
- Punyashlok Ahilyadevi Holkar's Military Leadership, administrative brilliance and patronage of temples and dharamshalas across India.
- Punyashlok Ahilyadevi Holkar's judicial acumen and direct involvement in people's welfare.
- Punyashlok Ahilyadevi Holkar's legacy as a woman ruler in a patriarchal era, setting an example of ethical governance.

4.2 Creative Scope

- Develop an original screenplay rooted in historical research, oral traditions, and archival material.
- Create an emotionally resonant, visually rich, and globally appealing film.
- Integrate music, art direction, and performance that reflect 18th-century aesthetics.
- Employ experienced cast and crew capable of delivering high cinematic quality.
- The film will be made in Marathi and Hindi Language and with other regional languages as approved by MFSCDCL.
- Use of High-Resolution Cameras (Minimum 4K or Higher)
- Use of Spatial Sound Design (Dolby Atmos)
